We will join forces in creating an organizational culture of honesty, fostering and raising awareness of positive attitudes and values in the performance of duties, and the ability to automatically differentiate between public and private interests, putting public interests over personal interests, cultivating public spirit and public mind consciousness, performing duties with integrity, transparency, fairness and without discrimination, refraining from any act that may create a conflict of interest between public and private interests and from accepting any asset or benefit that may be convertible to financial value beyond the asset or benefit that can be justly obtained under the laws, rules or regulations issued by virtue of the provisions of law, except for the acceptance of gifts or benefits that are permitted by ethical reasons under the criteria and quantity determined by the National Anti-Corruption Commission.
